SIMON WAEVER Morgan Stanley

Simon has been with Morgan Stanley for 12 years and a member of the EM Strategy team since 2012. Starting with flow credit, he moved on to structured credit before becoming a manager within the Model Review Group.

Simon holds a BSc in mathematical sciences from the University of Bath and an MSc in finance and investment from Cass Business School.

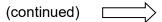
MUNIR JALIL BTG Pactual

Munir Jalil holds a BA in Economics from the Universidad del Valle and a Ph.D. in Economics from the University of California, San Diego.

Prior to joining Fitch in 2016, Richard was a Director for the sovereign group at Standard and Poor's where he covered numerous sovereigns in Latin America and the Caribbean (2000-15). Richard also worked at Morgan Stanley in the Latin American Economics Research Group (1998-2000).

Richard earned a BA in political science from Rice University and an MA in International Affairs from Columbia University. He was a Rotary Scholar studying economics at the Universidad del Salvador in Argentina.

BEN RAMSEY JPMorgan

Ben Ramsey heads J.P. Morgan's Latin America Economics Research team, managing regional economics products and leading the team's economists. He is also the Chief Economist for the Northern Andean region.

Ben first joined the J.P. Morgan Chase EM research team in 2000, and in 2002 he worked in J.P. Morgan's Sao Paulo office. He has covered sovereign credit events and restructurings in the Dominican Republic, Ecuador, and Venezuela.

He is a regular contributor to J.P. Morgan's flagship publications, such as *Emerging Markets Outlook and Strategy* and *Global Data Watch*. He has consistently been ranked for Latin America and Andean economics coverage by *Institutional Investor*, and has been recognized with several forecasting awards from *Consensus Economics*.

Ben has previously worked at CIDAC, an economic policy think-tank in Mexico City, and at the Council of the Americas in New York.

He holds an MA in international economics from the Johns Hopkins School of Advanced International Studies (SAIS). Ben speaks Spanish and Portuguese.
