Siobhan Morden heads Latin America Fixed Income Sovereign Strategy at Santander Investment Securities after the recent merger with Amherst Pierpont Securities and more than 30 years of experience. This reflects a similar role at Nomura and previously at Jefferies with a focus on distressed and stressed sovereign credits and RBS where she was Head of Latin America Strategy across local and external markets.

Previously, she was Head of Research & Strategy for North America and Head of Emerging Markets Latin America Research & Strategy at ABN AMRO. Prior to that, she was Head of Emerging Markets Research at Caboto (Banca Intesa), and a Senior Fixed Income Analyst at both PaineWebber and Santander Investment Securities.

Ms. Morden received an MA from New York University, a BA from Boston College and a graduate certificate in social economics and cooperative law from the Universidad del Pais Vasco in San Sebastian, Spain, where she was a Fulbright Scholar.
