PIN RU TAN (Moderator) HSBC

Pin Ru Tan is an Asia-Pacific rates strategist at HSBC Singapore, where she covers regional rates markets. Prior to joining HSBC in 2011, Pin Ru was an Asia FX and rates strategist with another financial institution. For a few years running, she has been voted among the top pan-Asia sell-side analysts in The Asset Survey.

Pin Ru holds a bachelor's degree in economics from Nanyang Technological University, Singapore, and was awarded a Lee Kuan Yew Gold Medal.

DAN WANG Eurasia Group

Dr Dan Wang is China Director for Eurasia Group, specializing in China's economy, industrial policy and geopolitics. She previously served as the Chief Economist at Hang Seng Bank China based in Shanghai, responsible for macroeconomic forecasting and capital market analysis. Before that, she was the Chief Analyst at the EIU, focusing on city development and China's overseas investment.

Dan holds a PhD in economics from the University of Washington, with expertise in property rights, environmental economics and econometrics. During her postdoc research at the Chinese Academy of Sciences, She designed and led nationwide surveys on agriculture commissioned by the Ministry of Agriculture and the State Council. She is a frequent voice in global media and writes a column for FT China. She regularly delivers keynote speeches at government and industry forums and participates in high-level policy discussions worldwide.
