#### KIERAN CURTIS (MODERATOR) Aberdeen

Kieran Curtis is the Head of Emerging Market Local Currency Debt within the Emerging Market Debt Team at abrdn. Kieran's main responsibilities cover sovereign debt, particularly local markets. Kieran began his investment career in 2002 at Invesco Asset Management before moving to Standard Bank.

Prior to joining Standard Life Investments in 2013, Kieran worked at Aviva Investors as Portfolio Manager and Head of Local Currency Bonds.

Kieran graduated with a Biochem (Hons) in Biochemistry from University of Oxford. Kieran also holds the IMC, and has passed CFA Level 1 & 2 Exams.

#### LUIS COSTA Citi

Luis Costa is a Managing Director at Citi Research. He runs the EM Global Strategy practice at Citi. He has been covering the EM markets, from both hard currency and local currency perspectives, for the last 20 years.

Prior to Citi, he worked at Commerzbank and at ING Wholesale Banking on EM Strategy positions.
